Rate Hikes Continue to Slow Housing **Market Activity and Create Market Uncertainties, HouseCanary's Latest Market Pulse Report Shows**

Interest Rates Surge to 22-Year Highs, Fueling Housing Market Uncertainties

Shift Towards Rental Market Intensifies as Purchasing Activity Declines, Represented by a 27.5% Year-Over-Year Decline in New Listing Volume

Closed Prices Continue to Rise as Listed Prices Reached Their Peak in June

Interest rates are now at the highest level seen in 22 years due to the Federal Reserve's efforts to combat the 3.3% year-over-year inflation growth observed in July. Federal Reserve officials and experts are now predicting rates to hike yet again in September, creating more uncertainty in the housing market and overall economy.

Homeowners and potential buyers continue to distance themselves from the purchase market and redirect their interest toward the rental market, as can be seen by the continuous year-over-year declines in purchasing market activity and rapidly increasing inventory of single-family rentals.

In addition, the low market activity has caused the net new listing volume to continue lagging in contract volume, which is decreasing total inventory further. Looking ahead to Q3 and beyond, market activity and inventory can be expected to remain low as more rate hikes from the Federal Reserve are likely to be introduced in the upcoming FOMC meetings.

In August, the housing market continued to show low net new listings and slow price increases, and with the latest round of rate hikes, these market conditions are only expected to linger.

Single-family rentals remain the most desired choice for potential homebuyers in the current uncertain market environment, as price and inventory increases on a year-over-year basis persist. Notably, single-family rental inventory is up 41.4% when compared to August 2022, while inventory in the purchasing market is down 12.5%. As we move into September, we can expect an additional rate hike to be set in the upcoming meeting, continuing the trend of low market activity we have been experiencing over the past year.

- 1. For the month of August, 216,619 net new listings were placed on the market which represents a 29.5% decrease versus August 2022. Over the last 52 weeks there have been 2,405,285 net new listings placed on the market. This represents a 27.9% decrease versus the year prior. Broken out by price bins, the \$0-\$200k bin has accounted for 14.5% of net new listings over the last 52 weeks, the \$200k-\$400k bin at 39.1% of net new listings, the \$400k-\$600k bin at 23.2% of net new listings, the \$600k-\$1m bin at 15.4% of net new listings, and the \$1m+ bin at 7.8% of net new listings.
- 2. The total volume of net new listings over the last 52 weeks for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m, and \$1m+ price bins are down 26.5%, 26.4%, 30.3%, 29.6% and 26.8% compared to the year prior. For the month of August net new listing volume for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m and \$1m+ price bins are down 23.3%, 34.3%, 33.4%, 23.8% and 11.6%, respectively, compared to August 2022.
- 3. For the month of August there were 256,777 listings that went under contract nationwide which is a 17.1% decrease versus August 2022. Over the last 52 weeks, 2,600,373 properties have gone into contract. This represents a 21.8% decrease versus the year prior. Broken out by price bins, the \$0-\$200k bin has accounted for 15.0% of total contract volume over the last 52 weeks, the \$200k-\$400k bin at 39.5%

of total contract volume, the \$400k-\$600k bin at 23.2% of total contract volume, the \$600k-\$1m bin at 15.1% of total contract volume, and the \$1m+ bin at 7.2% of total contract volume.

- 4. The total volume of listings going into contract over the last 52 weeks for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m and \$1m+ price bins are down 22.1%, 20.2%, 22.5%, 23.1% and 24.7% compared to the year prior. For the month of August, contract volume for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m, and \$1m+ price bins are down 12.3%, 18.1%, 19.7%, 17.6% and 11.1%, respectively, compared to August 2022.
- 5. For the week ending August 25th 2023, the median price of all single-family listings in the US was \$438,526 and the median closed price was \$419,403. On a year-over-year basis, the median price of all single-family listings is up 1.2% and the median price of closed listings is up 5.0%. Month-over-month, the median price of single-family listings is down 1.4% and the median price of closed listings is up 0.9%.
- 6. For the week ending August 25th 2023, the median price of all single-family rental listings in the US was \$2,614. On a year-over-year basis, the median price of all single-family rental listings is up 1.1%. Month-over-month, the median price of single-family rental listings is down 0.8%.

Coverage and Methodology

The core data used by HouseCanary to generate real estate analytics comes from public records, such as county tax assessors and recording offices, and from various multiple listings services. Public records typically record transactions on a time lag ranging from several days to several months, whereas data from various multiple listings services are updated as fast as every 15 minutes.

As a nationwide brokerage, HouseCanary's participation in a majority of multiple listing services (MLS) across the United States make it uniquely positioned to provide a timely and comprehensive Single Family Home property analysis based only on information from various multiple listings services. On a weekly basis, HouseCanary aggregates and analyzes 22 key metrics for all single-family detached homes observed on HouseCanary's home search platform as part of this Market Pulse.

Executive Summary - Week Ending August 25, 2023

- Market activity in terms of net new listing volume remains sharply down year-over-year.
- Net new listing volume continues lagging contract volume, putting further downward pressure on inventory.
- Listed and closed prices both achieved positive growth on a year-over-year basis in June. List prices appear to have peaked in June while closed prices continue increasing.

Contract Volume and Net New Listing Volume:

- Over the last 52 weeks, 2,405,285 net new listings were placed on the market, and 2,600,373 properties went under contract. This represents a decrease of 27.9% and 21.8%, respectively.
- For the month of August 2023, 216,619 net new listings were placed on the market, and 256,777 properties went under contract. This represents a decrease of 29.5% and 17.1%, respectively, versus August 2022.
- The decrease in net new listings was driven by a 27.5% decrease in new listing volume as well as a 18.9% decrease in removals compared to August 2022.





Figure 1: Annual Contracts and Net New Listings

- The interest rate shock is having the biggest impact on net new listing volume which remains sharply down year-over-year. Contract volume is also down year-over-year, but not as much.
- Net new listing and contract volume are trending at multi-year seasonal lows.
- Total inventory is down 12.5% from the same period in 2022, and down 10.7% from 2021. Inventory remains very low from a historical perspective.




Figure 3: Contract versus Net New Listing Volume

- Median days on market stands at 37. This is about the same as it was one year prior at 37 days on market.
- Months of inventory currently stands at 3.68 months. The current value implies a seller's market environment

Figure 5: Days on Market







Figure 6: Months of Inventory

- The total volume of net new listings over the last 52 weeks are down across all price bins compared to the year prior.

Single Family Price Activity:

- The median price of all single-family listings in the US was \$438,526 and the median closed price was \$419,403. On a year-over-year basis, the median price of all single-family listings is up 1.2% and the median price of closed listings is up 5.0%. Month-over-month, the median price of single-family listings is down 1.4% and the median price of closed listings is up 0.9%.
- The median price-per-sqft of all listed single-family homes in the US sits at \$226.8 and the median closed price-per-sqft was \$230.4. On a year-over-year basis, the median price-per-sqft of all listed single-family homes is down 0.1% and the median price-per-sqft of closed listings is up 4.8%. Month-over-month, the median price-per-sqft of all listed single-family homes is down 0.7% and the median price-per-sqft of closed listings is up 1.3%.







Figure 8: Median Listed and Closed Price


- The sale-to-list-price ratio stands at 99.3% which is well above the lowest value observed in January 2023.
- Price cuts are down 33.9% compared to the same time last year, and are down approximately 35.6% from their peaks occurring in September and October 2022.



Figure 13: Median Listed Monthly Rental Price






