New Listing and Contract Volume Decreased in January as Low Market Activity Persists, Latest **HouseCanary Report Shows**

Net New Listing and Contract Volume Down Versus January 2023

Stagnating Rates Continue to Keep Buyers and Sellers at Bay

Interest Rate Shock Continues to Keep Inventory at Historically Low Levels

As we enter the new year, the Federal Reserve has indicated its intention to halt interest rate hikes for the time being. The Fed also made clear that it has no immediate intention to lower those rates. As a result, rates will continue to hover around 6.5%-7%, and we expect recently observed trends in the housing market to continue. For the month of January 2024, market activity remained low in terms of net new listings, down sharply compared to January 2023, and contract volume, slightly down compared to January 2023.

In December, we saw a slight increase in year-over-year listings as potential buyers and sellers became slightly more comfortable with slightly lowered interest rates. These trends did not, however, continue into the new year. New listings and contract volume are trending at multi-year seasonal lows, and both down compared to January 2023. While inventory is up compared to January of last year, it still remains very low from a historical perspective. With the Federal Reserve indicating that rates will stay at current levels as inflation remains above their 2% target and dashing hopes of a March rate cut, there remains little incentive for potential buyers and sellers to abandon their current mortgage rates.

1. For the month of January 2024, 131,050 net new listings were placed on the market which represents a 17.2% decrease versus January 2023. Over the last 52 weeks there have been 2,481,822 net new listings placed on the market. This represents a 17.5% decrease versus the year prior. Broken out by price bins, the \$0-\$200k bin has

accounted for 13.5% of net new listings over the last 52 weeks, the \$200k-\$400k bin at 38.7% of net new listings, the \$400k-\$600k bin at 23.6% of net new listings, the \$600k-\$1m bin at 15.9% of net new listings, and the \$1m+ bin at 8.3% of net new listings.

- 2. The total volume of net new listings over the last 52 weeks for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m, and \$1m+ price bins are down 19.5%, 17.1%, 19.1%, 16.8% and 12.3% compared to the year prior. For the month of January 2024 net new listing volume for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k and \$600k-\$1m price bins are down 18.4%, 24.7%, 16.5% and 6.5%, respectively, while the \$1m+ price bin is up 5.8%, compared to January 2023.
- 3. For the month of January 2024 there were 186,284 listings that went under contract nationwide which is a 2.0% decrease versus January 2023. Over the last 52 weeks, 2,573,715 properties have gone into contract. This represents a 12.7% decrease versus the year prior. Broken out by price bins, the \$0-\$200k bin has accounted for 14.1% of total contract volume over the last 52 weeks, the \$200k-\$400k bin at 39.3% of total contract volume, the \$400k-\$600k bin at 23.5% of total contract volume, the \$600k-\$1m bin at 15.5% of total contract volume, and the \$1m+ bin at 7.6% of total contract volume.
- 4. The total volume of listings going into contract over the last 52 weeks for the \$0-\$200k, \$200k-\$400k, \$400k-\$600k, \$600k-\$1m and \$1m+ price bins are down 16.1%, 11.2%, 13.3%, 12.8% and 11.4% compared to the year prior. For the month of January 2024, contract volume for the \$0-\$200k and \$200k-\$400k price bins are down 4.6% and 6.0%, respectively, while \$400k-\$600k, \$600k-\$1m and \$1m+ price bins are up 0.0%, 4.5% and 11.7%, respectively, compared to January 2023.
- 5. For the week ending January 26th 2024, the median price of all single-family listings in the US was \$428,958 and the median closed price was \$396,646. On a year-over-year basis, the median price of all single-family listings is up 3.8% and the median price of closed listings is up 8.1%. Month-over-month, the median price of single-family listings is up 0.6% and the median price of closed listings is up 2.1%.

6. For the week ending January 26th 2024, the median price of all single-family rental listings in the US was \$2,538. On a year-over-year basis, the median price of all single-family rental listings is up 3.5%. Month-over-month, the median price of single-family rental listings is up 0.2%.

Coverage and Methodology

The core data used by HouseCanary to generate real estate analytics comes from public records, such as county tax assessors and recording offices, and from various multiple listings services. Public records typically record transactions on a time lag ranging from several days to several months, whereas data from various multiple listings services are updated as fast as every 15 minutes.

As a nationwide brokerage, HouseCanary's participation in a majority of multiple listing services (MLS) across the United States make it uniquely positioned to provide a timely and comprehensive Single Family Home property analysis based only on information from various multiple listings services. On a weekly basis, HouseCanary aggregates and analyzes 22 key metrics for all single-family detached homes observed on HouseCanary's home search platform as part of this Market Pulse.




Figure 1: HouseCanary nationwide brokerage coverage map.

Executive Summary - Week Ending January 26, 2024

- For the month of January 2024, market activity in terms of both net new listing and contract volumes are slightly down compared to January 2023, and remain sharply down over the last 52 weeks.
- Net new listing volume continues lagging contract volume, putting further downward pressure on inventory.
- Listed and closed prices both achieved positive growth on a year-over-year basis in January 2024. List prices and closed prices appear to have peaked in June and August 2023, respectively.

Contract Volume and Net New Listing Volume:

- Over the last 52 weeks, 2,481,822 net new listings were placed on the market, and 2,573,715 properties went under contract. This represents a decrease of 17.5% and 12.7%, respectively.
- For the month of January 2024, 131,050 net new listings were placed on the market, and 186,284 properties went under contract. This represents a decrease of 17.2% and 2.0%, respectively, versus January 2023.
- The decrease in net new listings was driven by a 14.2% decrease in new listing volume as well as a 6.3% decrease in removals compared to January 2023.





Figure 1: Annual Contracts and Net New Listings

- The interest rate shock is having the biggest impact on net new listing volume which remains sharply down year-over-year. Contract volume is also down year-over-year, but not as much.
- Net new listing and contract volume are trending at multi-year seasonal lows.
- Total inventory is up 7.9% from the same period in 2023, and up 24.8% from 2022. Inventory remains very low from a historical perspective.





Figure 3: Contract versus Net New Listing Volume

Figure 5: Days on Market





Figure 6: Months of Inventory

Contract Volume and Net New Listing Volume by Price Tier:

- Contract volume in January 2024 is down for lower price tiers and up for higher price tiers compared to January 2023.
- Net new listing volume in January 2024 is down for all price tiers except the \$1m+ price bin compared to January 2023.
- The total volume of listings going into contract over the last 52 weeks are down across all price bins compared to the year prior.
- The total volume of net new listings over the last 52 weeks are down across all price bins compared to the year prior.

Single Family Price Activity:

- The median price of all single-family listings in the US was \$428,958 and the median closed price was \$396,646. On a year-over-year basis, the median price of all single-family listings is up 3.8% and the median price of closed listings is up 8.1%. Month-over-month, the median price of single-family listings is up 0.6% and the median price of closed listings is up 2.1%.
- The median price-per-sqft of all listed single-family homes in the US sits at \$225.5 and the median closed • price-per-sqft was \$223.0. On a year-over-year basis, the median price-per-sqft of all listed single-family homes is up 3.7% and the median price-per-sqft of closed listings is up 8.0%. Month-over-month, the median price-per-sqft of all listed single-family homes is up 1.0% and the median price-per-sqft of closed listings is up 2.4%.








Figure 9: Median Listed and Closed Price-per-sqft





- Price cuts are down 9.1% compared to the same time last year.




US Single-Family Rental Summary:
